the Investigation Committee on the Land and Immovable Property of Tribhuvan University (TU). Of the total 5,050 acres of land originally acquired by the government for the establishment and operation of TU, approximately <u>2,539 acres have been found to be encroached.</u> In Kirtipur alone, more than 1,500 ropani of TU's land is illegally occupied by 18 institutions, including religious institutions. The report shows that the encroached 843 ropanis land is registered under government, private, non-governmental and religious institutions. Additionally, 696 ropani of land outside Kritipur has been misappropriated. The report further states that the failure to protect TU's land involves the responsibility of the then Prime Minister, Minister of Education, Vice-Chancellor of TU, Registrar among others.

Sharada Prasad Trital, formed on May 31, 2023, and submitted in the presence of then Education Minister Bidya Bhattarai. The committee conducted extensive studies of TU's land and other immovable properties in Kirtipur, Naikap, Dhungeadda, and Patan. protect Tribhuvan University's (TU) land: • Negligence of TU officials: University officials neglected their legal

- responsibilities by failing to document and update land records, contributing to the improper distribution and usage of land and breaches of contract. The committee identified several authorities including the TU Assembly, the Prime Minister (as Chancellor), and the Minister of Education responsible for this negligence. Political interference: Political influence and collusion among political
- leaders had led to the misuse and encroachment of university land. Political pressure, vested interests, and favoritism dominated the process of land distribution. • Lack of cooperation from government bodies: Despite repeated requests from TU to the Ministry of Education for assistance in land registration,
- ownership transfer, and record updating, the ministry and other concerned agencies failed to coordinate and support. • Involvement of TU employees: The committee observed that certain Tribhuvan University (TU) staff were directly implicated in or enabled land encroachment. This was due to their extreme negligence, failure to uphold

their legal obligations, and inaction in filing complaints or taking decisive

 Weak legal and policy mechanisms: The growing tendency to encroach on public land and the absence of clear legal and policy provisions for land protection were also identified as contributing factors. The extensive landholding of TU is the missed opportunity for significant

advancements. These lands could have been utilized for research and innovation hubs, fostering academic growth, providing student residences, and developing modern infrastructure, each of which would promote accessible and equitable education. Further with a transparent mechanism in place this could even have generated substantial income for the university. Beyond these missed possibilities, the situation highlights deeper structural issues: a lack of strict land management policies, inadequate government

records of public assets, and the absence of transparent mechanisms for land

usage and monitoring that creates a ripe environment for manipulation and encroachment. The case of TU land misappropriation is not a new phenomenon and rather reflects a profound crisis of morality, institutional values, transparency, and deeply rooted corruption within public institutions of Nepal. It is imperative that the response does not follow the usual pattern—limited to public outrage and inaction. Instead, this moment must mark a turning point leading to the full recovery of encroached land and the prosecution of those responsible. Read more

3. Government recalls 11 ambassadors: The interim government has recalled 11 ambassadors, directing them to return to Nepal by November 6, 2025. The recall includes envoys to China, Germany, Israel, Malaysia, Qatar, Russia, Saudi Arabia, Spain, the UK, the US, and Japan. These ambassadors were appointed under a

Corruption charges against a member of the Madhesh Province Assembly and 15 others: The Commission for the Investigation of Abuse of Authority (CIAA) has filed corruption charges against 16
- individuals. Among them are Saroj Kumar Singh, a member of the Madhesh Province Assembly and former minister, as well as the chair and treasurer of several consumer groups. The specific consumer group chairs and treasurers involved were responsible for the construction of a Dharmashala, the completion and beautification of a temple, road gravelling, etc. They are accused of embezzling Rs 3.8 million, an amount reportedly transferred to Singh's wife. - 5. 43 local units remain to submit a budget for fiscal year 2025/26: Three months after the fiscal year ended, 43 among the 753 local units have yet to announce their annual budgets, despite the legal mandate to do so by Ashad 10. Of these, 34 are from Madhesh Province alone. Officials attribute the delay largely to political disagreements among local representatives, which have stalled budget approvals. The prolonged stalemate has raised concerns
